- 3. Nature of Hearing: The hearing will be a public opportunity for interested parties to present evidence and argument relevant to the issuance of orders under Iowa Code § 507B.4C (2014).
- 4. **Legal Authority**: The hearing will be held to implement to the authority under Iowa Code § 507B.4C(5) (2014). This section provides:

*Orders.* The commissioner may issue an order doing any of the following:

a. Limiting the death master file comparisons required under subsection 3, paragraph "a", to an insurer's electronic searchable files or approving a plan and timeline for conversion of an insurer's files to electronic searchable files.

- b. Exempting an insurer from the death master file comparisons required under subsection 3, paragraph "a", or permitting an insurer to perform such comparisons less frequently than semiannually upon a demonstration of financial hardship by the insurer.
- c. Phasing in requirements for compliance with this section according to a plan and timeline approved by the commissioner.
- 5. Comment Enrollment and Written Comments: Interested parties that wish to present information and comment at the hearing are encouraged to enroll for the hearing by sending a written notice of intent to First Deputy Jim Mumford of the Iowa Insurance Division no later than October 2, 2014. The Division will receive written comment prior to and during the hearing. If any interested party wishes to present information and comment, it may submit written or oral comment at the hearing or in writing prior to the hearing by mailing the information and comment to:
