**ORDER REINSTATING LICENSE  
AFTER SUSPENSION**

IID File No.: 85227

Pursuant to Iowa Code chapter 17A and IAC 191-10.10, this matter comes before the Commissioner of Insurance upon an application by Christine Bennett for the reinstatement of his Iowa insurance producer's license.

**PARTIES AND JURISDICTION**

1. The Commissioner of Insurance, Nick Gerhart, administers and enforces the Iowa Licensing of Insurance Producers Act, Chapter 522B, pursuant to Iowa Code § 505.8 (2013).

2. Christine L. Bennett ("Bennett") is an individual with a last known mailing address of 8610 EP True Pkwy #13012, West Des Moines, IA 50266.

3. Bennett has filed an application with the Iowa Insurance Division ("Division") for reinstatement of her suspended license and the Division is authorized to issue this Order pursuant to 191 IAC 10.10.

**FINDINGS OF FACT**

4. Bennett is licensed as a resident insurance producer in the State of Iowa.

5. On October 16, 2014, a suspension order was issued by the Division that stated that Bennett's "insurance producer's license was suspended effective the date of the order."

6. The Division's letter notifying Bennett of such intended suspension was sent on September 15, 2014. Based on the language of the required notice of intended suspension Bennett was advised that the Iowa Department of Human Services ("DHS") had to withdraw the Certificate of Noncompliance, prior to Bennett's license becoming reinstated by the Division.

7. DHS withdrew the Certificate of Noncompliance on October 23, 2014.

8. Bennett's suspension provided for in the suspension order has been served as Bennett has met the requirements of DHS.

9. On November 3, 2014, Bennett filed an application for reinstatement after suspension of her insurance producer license as required by 191 IAC 10.10.

10. As Bennett has complied with the suspension and filed the necessary reinstatement application, an order of reinstatement of her Iowa insurance producer's license will be issued.

### **CONCLUSIONS OF LAW**

11. Bennett is in compliance with the terms of her suspension found in the suspension order issued by the Division dated October 16, 2014 and has filed the required application of reinstatement so an order of reinstatement should be issued pursuant to 191 IAC 10.10.

THEREFORE, IT IS ORDERED THAT:

1. The Iowa resident insurance producer license of Bennett is no longer suspended;

2. Bennett shall immediately be able to transact and participate in the business of insurance in Iowa.



This matter comes before the Iowa Insurance Commissioner upon submission of a Certificate of Noncompliance from the Iowa Department of Human Services (“DHS”). Under Iowa Code section 272J.8 (2013) and Iowa Administrative Code, rule 191-10.21, the Iowa Insurance Commissioner was required to issue a notice to **Christine L. Bennett** (“Respondent”) advising Respondent that the Certificate of Noncompliance was received and that Respondent’s Iowa insurance producer license would be suspended in 30 days unless DHS withdrew the Certificate of Noncompliance within those 30 days. The Iowa Insurance Division’s letter notifying Respondent of the intended suspension was sent on September 15, 2014. Therefore, the thirty-day notice period has now passed.

The Iowa Insurance Commissioner has authority to order the suspension of the insurance producer license of Respondent pursuant to Iowa Code section 252J.8 (2013) and Iowa Administrative Code, rule 191-10.21.

THEREFORE, IT IS ORDERED:

The Iowa insurance producer license of **Christine L. Bennett** is suspended as of the date of this Order.
